Local artists are invited to display their artwork on the walls of the Neighborhood Guild. Pick up an application form, available at the Neighborhood Guild or online at www.southkingstownri.com. Applications to exhibit will be considered on the basis of originality, artistic quality, and suitability for a family setting. Exhibits will normally run for three months: July 15 to October 14, October 15 to January 14, January 15 to April 14 and April 15 to July 14. Completed application forms should be turned in at that the Neighborhood Guild.

All Artists in Washington County who work in 2D media are eligible to apply. All artwork must be original work by the submitting artist. No copies of other artist's work will be accepted. No works depicting nude figures will be accepted. There is no charge to display your work and the Parks and Recreation Department does not take commission on work sold at the display nor does it handle any sales that might result from the display. The Artist is responsible for making the title cards to be displayed with the painting. Title cards (business card size/printed and not hand written) should contain the artist's contact information so that sales can be handled directly between the artist and the customer. Artwork does not have to be for sale. Individuals are responsible for the setting up and taking down of their artwork. The South Kingstown Parks and Recreation Department reserves the right to refuse to hang works that it deems objectionable or unqualified for showing.

All work must be properly framed and ready to be hung as follows. Watercolors and photographs should be framed and have plexiglass protecting the face of the art. Wrap-around canvases will be accepted without frames provided the painting continues around the outside edge and does not have staples on the outside edges. All framed work must have suitable wire to accommodate the weight of the work. Oils and acrylics should be thoroughly dry prior to exhibiting. I understand that artwork that is not framed appropriately may be rejected.

I acknowledge that my property, including, without limitation, any art or other items on display (collectively to be known as the "Property") may be damaged, lost or stolen during the exhibition and I acknowledge and understand the risk involved by allowing such property to be displayed by the South Kingstown Parks and Recreation Department located at 325 Columbia Street, Peace Dale, RI 02879. I understand that the South Kingstown Parks and Recreation Department, The South Kingstown Recreation Commission and the Town of South Kingstown do not insure the Property and if I so choose I must acquire my own insurance. If I so choose such insurance, I agree to submit a copy to the Parks and Recreation Department. I understand that I am responsible for the hanging or display of any Property and must get prior approval of any signage from the South Kingstown Parks and Recreation Department. The term of the Exhibition begins when the Artwork(s) are delivered to the Neighborhood Guild, and shall run through the agreed upon Exhibit end date. I agree that I will have a period of no longer than seven business days to remove any and all property from the Neighborhood Guild if either The South Kingstown Parks and Recreation Department, The South Kingstown Recreation Commission or The Town of South Kingstown or the Lender chooses to terminate their exhibition before the specified exhibit end date.
